1. See a proof of your cover. A photocopy of your insurance policy must be included when you return this form.

2. If you cannot produce a copy of your insurance, which must be valid until after our show then:

3. We are instructed that we must collect \$32.00 (GST inc) from everyone who does not have, or cannot provide proof of their own cover.

This will cover you for the duration of the show.

No site will be allocated unless you have the necessary insurance.

PLEASE NOTE: as from 11th March 2004 all amusement rides must have their own public liability cover of \$20 MILLION.
